

### **Discussion Overview**

January 2020 marked the first cases of the SARS-COVID-19 virus in the United States and by Mid-March, all 50 states had reported cases of Covid-19. Throughout that time, the U.S. has experienced multiple challenges such as the overwhelming of healthcare systems, lack of proper PPE for healthcare professionals, fiscal turmoil secondary to the need to shutdown businesses (i.e., restaurants, sporting events, entertainment venues, etc.). According to the CDC, the current U.S. cases of COVID-19 is over 41 million with a death toil that has surpassed over 650,000; worldwide, there has been over 219 million cases of COVID-19 and over 4.55 million deaths.

With the development of (3) COVID-19 vaccines (Pfizer, Moderna and J&J), which have varying but similar efficacy levels, one would think that we'd be on the downward trend of the pandemic and could be seeing "the light at the end of the tunnel." However, even with the development of the (3) vaccines, the U.S. still lags in Americans getting vaccinated. In addition, there remains many persons that are skeptical of the actual existence of the COVID-19 virus as well as mistrust in the science and in the government. The emergence of persons who are opposed to vaccinations (i.e., anti-vaxxers) and other methods of protection (i.e., "anti-maskers") have compounded the efforts to decrease transmission of the virus.

#### Objectives

To provide discussion on the COVID-19 virus by defining what a virus is and what a vaccine. In addition, I will touch on common myths, misinformation, personal belief, medical mistrust and disparities among minority communities that are barriers to individuals getting vaccinated. The effects on the church and the need to apt to changes in how worship services are conducted, continued safety measures will also be addressed.


#### Definition of a Virus

According to the CDC, a virus is defined as "A tiny organism that multiplies within cells and causes disease; Viruses are not affected by antibiotics, (drugs used to kill bacteria.")

Viruses are genetic material that consist of DNA or RNA and is protected by protein wrapping. Upon transmission of a virus, the replication process begins by binding to a cell's surface receptors inside of a host. The original genetic information of that cell is overwritten due to the replication process and as more and more cells are replicated/infected, the host's immune system is activated, causing an immune response (e.g., fever, chills, shortness of breath, headaches, nausea, vomiting, diarrhea, etc. (Reference Website: <u>www.cdc.gov</u>).

#### Definition of a Vaccine



# Visual Depiction of the Covid-19 Virus Transmission



#### Some Common Myths, Personal Beliefs and Misinformation regarding the Covid-19 Vaccines


- I don't believe that the COVID-19 virus exist; It's something that the federal government made up as a scare tactic & to control people.






## Covid-19 Virus and the Delta Variant

- The Delta Variant is currently the predominate variant of the COVID-19 virus in the U.S. It is more contagious; in fact, it is 2x as contagious than previous strains and spreads faster than earlier forms of the COVID-19 virus.
- The Delta Variant accounts for more than 80% of cases reported in the U.S.
- Unvaccinated people are the most at risk for developing severe illness.






Delta Variant Strain – 2x the potential of infection transmission

## Safety Measures to reduce/prevent the transmission of COVID-19/Delta Variant

# • Please, Please, Please, Get Vaccinated!!

- The CDC is recommending that individuals who are immunocompromised and healthcare workers receive a booster vaccine 8 months after receiving their second vaccine injection (Pfizer/Moderna)
- Continue to wear facial coverings/face masks indoors and even outdoors when among crowds of people
- Hand Washing/Hand Sanitation
- Limit/eliminate modes of transmission opportunities (i.e., avoid usage of in-pew materials such as hymnals, offering envelops, visitors' cards, etc.).
- Continue to Social Distance Limit holding in-person administrative meetings, choir rehearsals, etc. (if possible), by utilizing various virtual meeting apps (i.e., Zoom, Microsoft Teams, etc.)
